VISITATION RULES:

A member will be considered "in arrears" of their visitation requirements, if they have not completed the previous month's visitation as of the visitation day of the following month.

If a member is "in arrears" one (1) visitation, the membership will be considered a "Member Not in Good Standing"

Upon a member being "in arrears" two (2) visitations, the membership will be terminated immediately.

A member has the right to bring their concerns before the board at any monthly board meeting. Board meetings are held on the Tuesday of the month, prior to the first Wednesday of the month at 7 AM.

Visitation Chair: Lisa Kilpatrick, 717-545-5215

A. Attend a 30-60 minute visitation to learn about the member and product, then give a 30-45 second commercial at the last meeting of each month.

B. Any member not in attendance at the last meeting will report on the visitation the next meeting.

C. All visitations are MANDATORY; a \$5.00 cumulative increasing fine must be paid for EACH WEEK an individual visitation is in arrears. The fist \$5.00 is paid to the visitee, then paid to the Visitation Chair thereafter.

D. If you are scheduled to speak or showboat and are in arrears on you visitations, you will forfeit your slot and pay the appropriate fine.

E. If your visitations are in arrears you may not give your own "commercial" until visitations and fines are brought current.

F. If you are having difficulty contacting your Visitee, let the Visitation chair know before months end to help expedite the process.

G. If you haven't done your visitation, when the tip bucket is passed to you, stand up, announce that you didn't do your visitation, then go over to the person you were to visit and pay them the \$5.00 you owe them!

H. If visitee not present, give the \$5.00 to the Visitation Chairman who will mark you as paid and deliver the fine to the visitee.

I. After the first week fine is paid to the visitee, pay the VISITATION CHAIR the \$5.00 every week until visitation commercial is given.

Do not put the fine in the bucket, fine must presented to the Visistation Chair, which will be given to the Treasurer.
